Copies of the Petition/Notice of Hearing and any attachments will be provided to the petitioner. > The petitioner is responsible for serving the Petition, Notice of Hearing and any attachments at least 7 days prior to the hearing as follows: by certified mail or personal service on all interested persons listed on the petition. > A Guardian ad Litem (GAL) will be appointed for the minor in a full guardianship proceeding. The Court will determine who shall pay the GAL's fees.
