SCHEDULING HEARING/SERVICE OF DOCUMENTS:
<ul> <li>A hearing will be scheduled within 45 days of the receipt of the Petition. Copies of the Petition/Notice of Hearing and any attachments will be provided to the petitioner.</li> <li>The petitioner is responsible for serving the Petition, Notice of Hearing and any attachments at least 7 days prior to the hearing as follows: by certified mail or personal service on all interested persons listed on the petition.</li> <li>A Guardian ad Litem (GAL) will be appointed for the minor in a limited guardianship proceeding. The Court will determine who shall pay the GAL's fees.</li> </ul>
