TO OPEN A LIMITED GUARDIANSHIP: read the following forms prior to completing them; once completed, file them with the Register in Probate office:

- ☐ JN-1501 Petition for Appointment of Guardian Full/Limited/Temporary/Emergency
- ☐ JD-1724 Notice of Hearing (Juvenile)
- ☐ GF-150 Uniform Child Custody Jurisdiction and Enforcement Act Affidavit
- ☐ JN-1514 Statement by Proposed Guardian
- ☐ JN-1510 Nomination of Guardian by Parent or Child

SCHEDULING HEARING/SERVICE OF DOCUMENTS:

- A hearing will be scheduled within 45 days of the receipt of the Petition. Copies of the Petition/Notice of Hearing and any attachments will be provided to the petitioner.
- The petitioner is responsible for serving the Petition, Notice of Hearing and any attachments at least 7 days prior to the hearing as follows: by certified mail or personal service on all interested persons listed on the petition.
- A Guardian ad Litem (GAL) will be appointed for the minor in a limited guardianship proceeding. The Court will determine who shall pay the GAL's fees.

PRIOR TO THE COURT HEARING: file all of the following documents with the Register in Probate office:

- ☐ JD-1825 Affidavit of Service (Chapter 48 and 938)
- ☐ Any other proof of service documents.
- ☐ [proposed] JN-1530 Letters of Guardianship and Dispositional Order Appointing Guardian Full, Limited or Temporary Guardianship
