SCHE	DULING HEARING/SERVICE OF DOCUMENTS:
>	The Register in Probate office will schedule a hearing on the temporary guardianship within 45 days of the receipt of the Petition.  The Petitioner is responsible for serving the Petition, Notice of Hearing and any attachments at least 7 days prior to the hearing as follows: by certified mail or personal service on all interested persons listed on the petition.  The Court will appoint a Guardian ad Litem (GAL) in a temporary guardianship proceeding. The Court will determine who shall pay the GAL's fees.

TIMEL	LINES:
A	The temporary guardianship is valid for 180 days and can be renewed for once for an additional 180 days.  A Request to extend the temporary guardianship must be filed with the Court <b>prior</b> to the expiration of the first 180 days.

- ➤ If the Court does not timely receive the forms: Request to Modify Guardianship, Extend Limited or Temporary Guardianship and a proposed Order on Request to Extend Limited or Temporary Guardianship, the temporary guardianship will expire.
- > The file will be closed and the temporary guardianship will expire after:
  - o The first 180 days expiration date (if not extended) OR
  - After the second 180 days expiration date.
  - o Only one extension may be granted.
- > During the term of the temporary guardianship, a hearing may be held *prior* to the expiration date to request a *full* or *limited* guardianship.

**CERTIFIED COPIES**: Certified copies of Orders are available from the Register in Probate Office. The certification fee is \$3.00, plus \$1.00 for each page copied and certified. Requests for certified copies may be made in person or by mail. If the request is by mail, please enclose the correct fee <u>and</u> a stamped, self-addressed return envelope. Payment must be received before the issuance of certified copies.
