2.2 Public Involvement and Participation

Chippewa County encourages the public to provide input and engagement in the County's MS4 programs by providing opportunities for the public to participate. Since it is the activities of the public within urbanized landscapes that produce non-point source pollution, the public can provide valuable input and assistance to the County's MS4 program. Through participation and volunteer opportunities the public can be actively apart of the implementation of the program.

The Public Involvement and Participation Program not limited to providing updates on the storm water regulations, hosts activities related to storm water management, and offers volunteer opportunities. As part of the public involvement, Chippewa County is a part of the stormwater consortium Rain to Rivers. The group has developed and provides a mini-grant program to encourage public involvement (Attachment 2.2 (A) & (B)). Projects that receive the Rain to Rivers mini-grant focuses on the installation of stormwater BMPs and public education that draws awareness to control practices and the impacts of stormwater.

Measurable Goals

- 1. Provide at least one opportunity annually for the public to provide input on the annual report, stormwater management program, and when applicable the adoption or amendment of stormwater related ordinances.
- 2. Provide at least one volunteer activity per year. These activities may include best management practice installation or maintenance, storm drain stenciling, planting community rain garden, clean up event, stream monitoring, citizen committee meeting, public workshop, presentation of stormwater information, or other hands on event.





Information

Rain to Rivers of Western Wisconsin, as part of its educational efforts, is offering small grants to organizations and entities looking to conduct specific storm water educational efforts.

Organizations such as non-profit groups, schools and government entities are eligible for these grants.

Requirements & Process

- Grants are for the purpose of storm water education
- Grants are small, with a <u>maximum amount</u> for any one grant of \$1,000
- Each grant application will be considered and accepted or denied based on its merits and consistency with grant criteria
- Proposals are expected to have a primarily educational purpose
- Public information regarding the activity would be encouraged (press releases, signage, etc.)
- Educational effort or organization is located within the jurisdictional boundaries of Rain to Rivers
- Funds will be distributed to approved projects on first-come, first-served basis
- Grant proposals will be evaluated on a regular basis by members of Rain to Rivers
- Number of grants awarded per year will be limited by availability of funds

Eligible Projects

- Storm water educational workshops/events
- Storm water field trips
- Installation of rain gardens to control storm water runoff
- Construction and installation of rain barrels to control storm water runoff
- Classroom events/lessons focused on storm water education
- Installation of pervious pavers or other pervious surfaces that allow infiltration of rainfall or runoff

Criteria/Considerations

- Strength of Educational Proposal—public exposure, a message consistent with Rain to Rivers messages
- Past Funding—Resources will be spread amongst organizations
- · Public outreach and informational effort
- · Geographical distribution of projects
- · Limit one grant per entity per year
- In-kind and matching support encourage
