Chippewa County Circuit Court Statement of Policy Deferred Payment Plans

- 1. The Court takes your fine obligation seriously and expects payment of the specified amount on the date agreed-upon by you **WITHOUT EXCEPTION**.
- 2. **All payment plans require a setup fee,** which must be paid before implementing a Deferred Payment Plan Agreement.
- 3. Payment plans must be set up within 14 days of conviction by signing a Deferred Payment Plan Agreement Contract. If the option to enter into a payment plan is declined, the fine *must* be paid within 30 days of the date of conviction, as required by Wis.Stats. Section 973.05.

- 5. If you fail to make the payments as ordered for a criminal or forfeiture violation, a commitment order will be issued, which means a warrant for your arrest will be issued. At that point, the full amount of the fine will be due immediately. Additionally, failing to pay may lead to interception of your tax refund, wage garnishment, and/or a civil judgment against you.
- 6. If you do not make the required payments for traffic or juvenile violations, your driving privileges will be suspended for one (1) year or until the payments are made. Additionally, failure to pay may lead to the interception of your tax refund, wage assignments, and/or a civil judgment against you.
- 7. If you do not make the required payments on any case type, the Wisconsin Department of Revenue will intercept your income tax refunds until your obligation is paid in full, as authorized by Wisconsin Statute 71.935. Payment plans longer than twelve months will be reported to the Department of Revenue upon implementation. Your social security number is needed for tax interception purposes.
- 8. The Clerk of Courts Office reserves the right to add additional fines to your payment plan as they become due.
- 9. If you have additional fines or financial obligations, you can add them to your payment plan for a \$5.00 fee. Please visit our office to process this request and avoid penalties for non-payment.
