**CALL MEETING TO ORDER**: Jankoski called the meeting to order at 3:35 p.m.

**CONSENT AGENDA:** Guthman and Davis made motion to approve the meeting agenda, and minutes from the October 28, 2024 meeting as printed, and scheduled the next meeting for January 27, 2024. Motion carried with all present voting aye.

## **DIRECTOR'S REPORTS:**

- 1. **Update on 738 Maple St Chippewa Falls:** Contractor submitted final payment, inspection done by Joel and to do list sent back to contractor, we will have Rick do some painting and clearing after to do list is completed by contractor.
- 2. **Update on 334 E 2<sup>nd</sup> Ave Stanley:** Contractor is done, Rick is working there as he can. We had some staff doing some painting there, Kitchen cabinets will be delivered and installed this month.
- 3. **Update on 17 W Birch St, Chippewa Falls:** Rick has not been able to work there. No updates.
- 4. **Update on Habitat House at 834 Bluffview Circle:** Working through final billing, Joel is doing final inspection 12/3/2024. We do have an occupancy permit from the city.
- 5. **Hope Village Updates:** They have an accepted offer on Indianhead Motel at this time, project total has changed, will go back to the county board for request to increase the amount for this project, closing set for March, will have LTE employee start 03/03/2025.
- 6. Section 8 Termination/Informal Hearing: waiting on judge's decision.

- 3. **Approval of updates to the Section 8 Administrative Plan:** Jankoski and Davis made a motion to approve the changes presented by Jessica Mudgett, Executive Director for the Section 8 Admin plan that are necessary and passed down by HUD. Motion carried with all present voting aye.
- 4. **Resolution 2024-12: To Approve Recommendations from Carlson Dettmann Consulting based on the market analysis of compensation of staff:** Guthman and Davis made a motion to approve the resolution and make the wage study recommended adjustments to staff wages as presented effective January 1, 2025. Motion carried with all present voting aye.
- 5. **Approval to increase pay scale by position effective January 1, 2025:** Davis and Jankoski made a motion to approve increase in pay scale by position for new hires as well as eliminate 6 month, 18 month and 30 month pay increases going forward and allow only for a yearly pay increase based on the wage study. Motion carried all others present voting aye.
