## **Explanatory Notes:**

- 1. Plan review fees are charged for initial plan reviews, and for significant plan changes.
- 2. Plan review fees are based upon the total anticipated area of the mine assuming the full "built out" mine scenario.
- 3. Proposed changes to a previously approved reclamation plan (that are proposed under an existing permit that serves to expand the permitted area or depth of the mine, or alter the scope of the operation) require a formal plan amendment and are subject to plan review. Plan review fees shall be charged based on the additional area added to the plan, or the additional time required to complete the plan review, plan amendment, and permit modification.
- 4. Plan review fees for bedrock mines more than 5 acres in size are established as base rate fees. Additional fees can be charged at a prescribed hourly rate (within any category) in circumstances where the service costs incurred by Chippewa County exceed the assigned base rate for the size category.
- 5. Plan review fees for bedrock mines more than 200 acres may be estimated and charged based upon the anticipated costs of time and materials to fully process the permit application.
- 6. In unzoned towns, public notice fees are \$100. Public hearing fees are \$500.
- 7. In zoned towns and areas subject to shoreland zoning, public notice and hearing fees under NR 135 will be waived, and charged at rates established by the zoning authority.
- 8. As a result of a DNR audit, fee categories have been combined to reflect the DNR fee schedule.
