CALL MEETING TO ORDER: Jankoski called the meeting to order at 8:00 a.m.

MEMBERS PRESENT: Jankoski, Davis, Martell, Guthman

OTHER ATTENDEES: Mudgett, Sengbusch

MEMBERS ABSENT: Danielson

CONSENT AGENDA: Guthman and Davis made motion to approve the meeting agenda, and minutes from the January 27, 2025 meeting as printed, and scheduled the next meeting for March 24, 2025. Motion carried with all present voting aye.

DIRECTOR'S REPORTS:

- 1. Update on 738 Maple St Chippewa Falls: Rick has some painting and cleaning he has been working on.
- 2. Update on 334 E 2nd Ave Stanley: We received 3 offers in one day. Have accepted one.
- 3. Update on 17 W Birch St, Chippewa Falls: Rick has not been able to work there. No updates.
- 4. **Hope Village Updates:** the state will only fund half of the project, they are seeking out other funding opportunities.
