## PUBLIC MEETING MINUTES CHIPPEWA COUNTY HOUSING AUTHORITY MONDAY APRIL 14, 2025 AT 3:30 PM ROOM 16 OF THE CHIPPEWA COUNTY COURTHOUSE

**CALL MEETING TO ORDER**: Martell called the meeting to order at 3:44 pm

**MEMBERS PRESENT:** Davis, Guthman, Martell

**OTHER ATTENDEES**: Mudgett, Chuck Hull

MEMBERS ABSENT: None, Martell arrived at 3:44pm

#### Members of the Public Wishing to be Heard:

Chuck Hull had a handout and presented in regard to recent meetings where a closed session was not on the agenda but was called by Martell. Hull explained Wisconsin Statutes 19.84 (2) stating every public notice of a meeting of a governmental body shall set forth the time, date, place and subject matter of the meeting, including that intended for consideration at any contemplated closed session. He included copies of recent agendas where a closed session wasn't listed and copies of minutes where a closed session was reported on the minutes. Hull further explained it may be in the best interest of the authority for Martell to step down as chair, for this meeting and going forward. Martell agreed.

Guthman/Martell made a motion for Guthman to act as chair at this meeting. All were in favor. Motion carried.
